- (1) Each restricted stock unit represents a contingent right to receive one share of Sanmina-SCI common stock.  
The restricted stock unit shall vest in full on October 15, 2012, provided, however: (1) if at any time during the first two years after the grant date, the 14-trading day average closing price of the Company's common stock equals or exceeds \$20.00 per share, then an aggregate of 25,000 RSU's shall vest on the second anniversary of the grant date; and (2) if at any time during the first two years after the grant date, the 14-trading day average closing price of the Company's common stock equals or exceeds \$30.00 per share, then an aggregate of an additional 25,000 RSU's shall vest on the second anniversary of the grant date.
- (3) The option vests in 4 year vesting schedule, 25% on October 15, 2010 and 1/36th of the remaining option to vest each month thereafter.
