Lambeau Field opened in 1957 and it s one of the most iconic NFL stadiums, and we have fans from all over the world come to visit. On non-game days, we serve anywhere from a thousand people down to a couple hundred people, depending on the day of the week. On game days the stadium seats 80,000 people. Safety for these fans and the workers and everybody involved here at Lambeau Field is the priority for games and any time of the year.

We have a lot of folks coming into Lambeau Field every game day and we really want them to - to enjoy their experience. We re here to provide security, fire, EMS and so forth and we really do not even want them to know that we re here and we want them to enjoy themselves and then go home at the end of the day safely.

The Simplex Grinnell systems are the number one thing that we use in the security office at the Green Bay Packers. The safety that they provide, the fire system that they provide is something that we rely on and we continue to use it because of the consistency it provides.

The relationship with the Green Bay Packers and Simplex Grinnell goes back about 30 some years. The system s evolved into a fully integrated Tyco fire and security solution.

During the game, we go into what we call game mode, so that we can monitor all of these systems within the stadium. That s actually done both in the security office and up in stadium control. We have the opportunity to watch anything that could possibly happen as far as fire incidents and fire alarms, smoke detectors and so forth.

We also have to be in some ways invisible. We need to be able to do our jobs and not interfere with their jobs, so it - it is a very tight-knit, close relationship.

The systems that we have here at Lambeau Field from Tyco and Simplex Grinnell are all smart systems that are integrated together. The technology is perfect, we know that it's reliable for us.

Green Bay is a small town and on a game day, there are more than 80,000 people here at Lambeau Field and those people are our friends, our neighbors, our relatives, people from across the state and around the world. We take that responsibility very seriously. You know, there's a lot of legends at Lambeau Field and Vince Lombardi is one of the most famous. I have one of the speeches up in my office and it starts out by saying "Winning is not a sometimes thing. You don't do things right once in a while, you do them right all the time." And that's exactly how we feel about Simplex Grinnell's work here at Lambeau Field. You don't do things right once in a while, you do them right all the time.
