No date has been set for Mr. Mehrberg's resignation, and he will continue to discharge his responsibilities until he leaves the company.

On October 29, 2007, the Board of Directors (Board) of ComEd appointed Peter V. Fazio, Jr. to the Board to fill a vacancy created by the expansion of the size of the Board.
