The Company expects to report a net loss of approximately \$(175,000) on revenues of approximately \$25,000 for the three months ended June 30, 2013 compared to net loss of approximately \$(506,000) on revenues of approximately \$974,000 for the quarter ended June 24, 2012. The anticipated net loss for the three months ended June 30, 2013 is primarily due to (i) the significant decrease in revenue due to the termination of two major contracts effective December 31, 2012 and (ii) the inability to reduce minimum fixed costs further.
