- (1) The exercise price of this option and the number of underlying shares are the same as those of the ten-year option granted to the reporting person on May 18, 2005, which was cancelled by the issuer on May 23, 2005 at the request of the reporting person because such option would have been required to be assigned to the reporting person's prior employer.
