The 11,480 shares of Common Stock represent a grant of performance-based restricted stock that shall vest one-third each year on the anniversary date of the issuance date if applicable performance conditions are achieved. Thus one-third may vest on each of July 20, 2013, July 20, 2014 and July 20, 2015.

(2) The options to purchase common stock vest one-third each year on the anniversary date of the purchase grant date. Thus one-third shall vest on each of July 20, 2013, July 20, 2014 and July 20, 2015.
