Unilever NV announces that on 2 October 2007 it purchased 500,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 21.530 and euro 22.020 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 15,054 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 97,297,945 Unilever NV ordinary shares in treasury, and has 1,617,429,755 Unilever NV ordinary shares in issue (excluding treasury shares).
