QVT Financial LP ( QVT Financial ) is the investment manager for QVT Fund LP (the Fund ), which beneficially owns 118,837 shares of Common Stock, QVT Overseas Ltd., which beneficially owns 207,261 shares of Common Stock, QVT Associates LP, which beneficially owns 73,947 shares of Common Stock and QVT Global II LP, which beneficially owns 83,806 shares of Common Stock. QVT Financial is also the investment manager for a separate discretionary account managed for Deutsche Bank AG (the Separate Account ), which holds 72,973 shares of Common Stock. QVT Financial has the power to direct the vote and disposition of the shares of Common Stock held by the Fund, QVT Overseas Ltd., QVT Associates LP, QVT Global II LP and the Separate Account. Accordingly, QVT Financial may be deemed to be the beneficial owner of an aggregate amount of 556,824 shares of Common Stock, consisting of the shares owned by the Fund, QVT Overseas Ltd., QVT Associates LP, QVT Global II LP and the shares held in the Separate Account.

QVT Financial GP LLC, as General Partner of QVT Financial, may be deemed to beneficially own the same number of shares of Common Stock reported by QVT Financial.

The reported share amounts for each reporting person reflect amounts held as of October 10, 2006, as adjusted for subsequent transactions through the date hereof.

Each of QVT Financial and QVT Financial GP LLC disclaim beneficial ownership of the shares of Common Stock owned by the Fund, QVT Overseas Ltd., QVT Associates LP, QVT Global II LP and the shares of Common Stock held in the Separate Account.
