The following communication related to the merger with Exelon was sent by Constellation Power Generation to its employees on July 5, 2011.

CPG employees,

I hope all of you had a safe and good Fourth of July holiday. As we now move into the dog days of summer, I wanted to touch base briefly with you on merger and divestiture activities and communications.

Over the past few weeks the integration process has been moving forward. At this point Constellation and Exelon are still in the analysis phase, so there's really not a lot of new information to report out that you don't already know. Last week's biggest development was the Maryland Public Service Commission (PSC) setting its merger hearing dates to begin in late October.

All that said, there are a number of communications vehicles that have been developed including a newsletter and an internal merger website that includes video interviews with the integration leads which provide good insight into the process. I know some of our plant locations outside Baltimore can have some challenges accessing our internal website, but I encourage all of you to read and watch as much of this information as you can. I think it's important we all understand the process and timing of the merger so we can be involved and continue to make a contribution throughout.

I'm also keenly aware that there are different circumstances and different questions for different groups. Certainly employees at the Baltimore coal plants will have different questions than employees in other parts of the business. This early in the process, however I think many of us have the same questions but many of the answers are not yet available. However in our continuing effort to keep you updated and engaged, CPG's leadership group is planning some Town Hall-type meetings for employees across the fleet in the next couple of weeks. This is part of an overall effort to answer your questions if we can and to ensure that we're keeping an open dialogue with all of you. More than anything we want to ensure you are not being distracted on the job by misinformation or rumors. Along those lines if you do have questions or issues please reach out to your HR rep or your supervisor.

Again, let me remind you that the merger and divestiture process is a marathon and not a sprint, and we have a long way to go. In the meantime we need to stay focused on meeting our goals in the plants and across the fleet. Of those goals none is more important than to continue to work safely. Please keep that at the forefront of your work and please look out for your co-workers as well as yourselves and your families.

In the meantime please keep working safely this summer. We will be in touch soon about setting up Town Hall meetings.
