- These grants were awarded to Mr. Probst in connection with his transition on September 27, 2008 to a non-employee Director of the Company and represent the pro rata number of shares that a non-employee Director of the Company would ordinarily receive automatically upon his or her annual re-election to the Board. These grants, including their grant date, were approved by the Board of Directors on July 31, 2008.
- (1) This option will first vest and become exercisable as to 100% of the underlying shares on the earlier of (i) the next Annual Meeting of Stockholders or (ii) 12 months from Vest Start Date. Optionee may then exercise the option with respect to vested shares at any time until expiration or cancellation.
 - (2) Each restricted stock unit represents a contingent right to receive one share of Electronic Arts common stock.
 - (3) The restricted stock unit award shall vest in its entirety and be deemed exercised on the earlier of (i) date of the next Annual Meeting of Stockholders or (ii) the one-year anniversary of the grant date.
