(1) Phantom Shares - amendment to filing to report 105 additional dividend equivalent units not reported on original filing.

The reporting person has elected to defer his trustee fees into phantom shares payable in ProLogis common shares. Phantom shares are generally payable when the reporting person ceases to be a trustee, at which time the phantom shares convert into ProLogis common shares on a 1-for-1 basis. Dividend Equivalent Units (DEUs) accrue on outstanding phantom shares which vest upon vesting of the related phantom shares. The receipt of such DEUs is deferred along with the related phantom shares and, upon receipt, such DEUs are paid in the form of ProLogis common shares at the rate of one common share per DEU. DEUs accrue at the ProLogis common share distribution rate at the time distributions on ProLogis common shares occur.
