**STAR BULK CARRIERS CORP. UPDATES ON OWNERSHIP  
OF INSIDER HOLDINGS**

**ATHENS, GREECE, July 30, 2008** Star Bulk Carriers Corp. (the Company or Star Bulk ) (NASDAQ: SBLK), announced today that F5 Capital, a company affiliated with Mr. Nobu Su, one of the Company's directors, filed a Schedule 13D report yesterday with the Securities and Exchange Commission to disclose its disposition of approximately 9.5 million Star Bulk common shares in certain private transactions. According to the Schedule 13D, F5 Capital's beneficial ownership in the Company has been reduced to approximately 3.8 million shares, representing roughly 7% of the Company's issued and outstanding shares. .

**Akis Tsirigakis, President and CEO of Star Bulk commented:** The sale of a number of Star Bulk shares held by a company affiliated with Nobu Su was effected with the consent of our Board of Directors. It does not affect our business plan and does not diminish our confidence in the positive outlook of the dry bulk sector and the prospects of

our company. Further, Mr. Su's affiliated company continues to be a significant shareholder. There has been no change in our Board of Directors and Mr. Su remains a Director. We welcome the higher free float and the potential for increased liquidity of our shares.

### **About Star Bulk**

Star Bulk is a global shipping company providing worldwide seaborne transportation solutions in the dry bulk sector. Star Bulk's vessels transport major bulks, which include iron ore, coal and grain and minor bulks such as bauxite, fertilizers and steel products. Star Bulk was incorporated in the Marshall Islands on December 13, 2006 and is headquartered in Athens, Greece. Its common stock and warrants trade on the NASDAQ Global Market under the symbols "SBLK" and "SBLKW" respectively. Currently, Star Bulk has an operating fleet of twelve dry bulk carriers, plus definitive agreements to acquire one Capesize dry bulk carrier and sell its Panamax dry bulk carrier. The total fleet consists of four Capesize, one Panamax and eight Supramax dry bulk vessels with an average age of approximately 10 years and a combined cargo carrying capacity of 1,184,835 deadweight tons.
