From January 18, 2008 through March 3, 2008, Master Fund acquired 133,200 shares of Common Stock in open market transactions for an aggregate purchase price of approximately \$1,281,100 using working capital.

(a) As of March 3, 2008, the Reporting Persons may be deemed to beneficially own 934,000 shares of Common Stock (which represents approximately 9.9% of the outstanding Common Stock based upon information contained in the Issuer s Form 10-Q for the quarter ended September 30, 2007).
