<b>Issuer</b>	Bank of America Corporation ( BAC )
<b>Principal Amount</b>	\$10.00 per unit
<b>Term</b>	Approximately two years
<b>Market Measure</b>	A basket of international indices comprised of the EURO STOXX 50® Index (Bloomberg symbol: SX5E ) and the JPX-Nikkei Index 400 (Bloomberg symbol: JPNK400 ). Each Basket Component is price return index. The EURO STOXX 50® Index will be given an initial weight of 75%, and the JPX-Nikkei Index 400 will be given an initial weight of 25%.
<b>Payout Profile at Maturity</b>	If the Market Measure is flat or increases up to the Step Up Value, a return equal to the Step Up Payment  If the Market Measure increases above the Step Up Value, a return equal to the percentage increase in the Market Measure
<b>Step Up Value</b>	1-to-1 downside exposure to decreases in the Market Measure, with up to 100% of your principal at risk [118% to 124%] of the Starting Value, to be determined on the pricing date
<b>Step Up Payment</b>	[\$1.80 to \$2.40] per unit, a [18% to 24%] return over the principal amount, to be determined on the pricing date
<b>Threshold Value</b>	100% of the Starting Value
