Item 1.01 Entry into a Material Definitive Agreement

On October 28, 2014, National Rural Utilities Cooperative Finance Corporation (“CFC”) amended the \$1,123 million four-year and \$1,068 million five-year revolving credit agreements to (i) increase the total aggregate amount of commitments under the four-year and five-year agreements to \$1,720 million and \$1,700 million, respectively, and (ii) extend the commitment termination date for the five-year agreement to October 28, 2019.

The foregoing summary is qualified in its entirety by reference to the full text of the amendments, which will be filed as exhibits to the Company's Quarterly Report on Form 10-Q for the fiscal quarter ended November 30, 2014.

Item 1.02 Termination of a Material Definitive Agreement

On October 28, 2014, CFC terminated the existing \$1,036 million three-year revolving credit agreement which was scheduled to mature on October 28, 2016.
