## REMARKS:

NOTE – The entity that is selling the shares referenced herein is MJG Management, LLC, a limited liability company of which Mario J. Gabelli is the managing member. GPJ Retirement Partners, LLC (“GPJ”) is a limited liability company which consists of retirement assets of Mario J. Gabelli and two other individuals who are employees of the adviser to the Issuer. Mr. Gabelli is a member of GPJ and is deemed to control the Issuer through his control of the investment adviser of the Issuer. GPJ and MJG Management, LLC are under the common control of Mario J. Gabelli.
