Subject to the successful completion of this offering, the Company will use the proceeds of the offering to retire a portion of its \$1.2 billion aggregate principal amount 8% Notes due July 8, 2003, by exercising the make-whole provision, and for general corporate purposes.

The securities have not been registered under the Securities Act of 1933 and may not be offered or sold in United States absent registration or an applicable exemption from registration requirements.

The press release does not constitute an offer to sell or the solicitation of an offer to buy the securities. Any offer of the securities will be made only by means of a private offering memorandum.
