1. 1,526,924 shares of common stock (which total includes 400,000 shares that Mr. Kasch pledged to Commerce Bank as collateral for a personal line of credit made by that Bank to Mr. Kasch);
  2. Options to acquire 300,000 shares of common stock granted on July 30, 2010, that vested over three years (with the final vesting increment on July 30, 2012), and that are exercisable for a five-year term at \$0.49 per share;
  3. Options to acquire 600,000 shares of common stock granted on July 19, 2011 (one-half vested on grant and the other half on July 19, 2012), and that are exercisable for a five-year term at \$1.10 per share; and
  4. Options to acquire 150,000 shares of common stock granted on June 5, 2012 and that are exercisable for a five-year term at \$0.46 per share.
5. Warrants to purchase 37,500 shares of common stock executed on November 2, 2012, and that are exercisable until November 30, 2017 at \$0.55 per share.
