EXPLANATORY NOTE

This Amendment No. 1 to Form 8-A amends and supplements the Registration Statement on Form 8-A filed by Plug Power Inc., a Delaware corporation (the <u>Company</u>), with the Securities and Exchange Commission on June 24, 2009 (including the exhibits thereto, the <u>Form 8-A</u>). Capitalized terms used without definition herein shall have the meaning set forth in the Shareholder Rights Agreement, dated June 23, 2009 (the <u>Rights Agreement</u>), between the Company and American Stock Transfer & Trust Company LLC, as rights agent.

Item 1. <u>Description of Registrant s Securities to be Registered.</u>

Item 1 of the Form 8-A is amended and supplemented by adding the following:

Amendment to Rights Agreement

On May 6, 2011, the Company entered into an Amendment to the Rights Agreement (the <u>Amendment</u>). The terms of the Amendment amend the Rights Agreement to provide that, generally, any deemed ownership of shares of Common Stock by OJSC INTER RAO UES, an open joint stock company organized under the laws of the Russian Federation (<u>INTER RAO</u>), and its Affiliates or Associates will not cause the Preferred Stock Purchase Rights to become exercisable under the Rights Agreement unless INTER RAO or such Affiliates or Associates acquire Beneficial Ownership of shares of Common Stock representing more than 34.09% (the <u>INTER RAO Grandfathered Percentage</u>) of the total outstanding shares of Common Stock. INTER RAO directly owns 81.9267% of the shares of OJSC Third Generation Company of the Wholesale Electricity Market, an open joint stock company organized under the laws of the Russian Federation (<u>OGK-3</u>). OGK-3 is the beneficial owner of 44,626,939 shares of Common Stock, or approximately 33.59% of the Company's outstanding shares of Common Stock. The INTER RAO Grandfathered Percentage represents 33.59% plus an additional 0.5%.

The Rights Agreement and the Amendment are filed as Exhibits 4.1 and 4.2, respectively, to this Amendment No. 1 to Form 8-A and incorporated herein by reference. The above description of the material terms of the Amendment as they relate to the Rights Agreement is qualified in its entirety by reference to such exhibits.

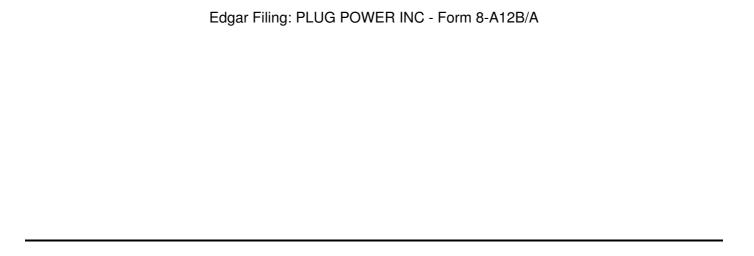
