After giving effect to this transfer, YIC owns no shares of Common Stock of Lotus Pacific, Inc. and Lotus International Holdings Corp., of which Mr. Yao is the majority stockholder, owns 5,631,999 shares of Common Stock of Lotus Pacific, Inc.
