(1) This amount includes 13,962 shares owned by Mr. Weed as previously reported on various forms 4. Of this total 9,596 shares are vested and the remainder will vest by August 1, 2006. All share amounts reflect the 1-for-20 reverse stock split effected by the Company on March 23, 2005.

(2) The options to acquire 13,462 shares of common stock reflect the forced conversion into common stock effected in February, 2005 and a 1-for-20 reverse stock split effected on March 23, 2005 concerning an option to acquire 350 shares of Series H preferred stock granted to Mr. Weed in 2003. Mr. Weed has previously reported this grant on a form 4.

(3) On October 26, 2005 the Board of Directors of the Company approved a grant to Mr. Weed of options to purchase 10,000 shares of common stock at a purchase price of \$4.88 per share. Options vest quarterly over 4 years in increments of 625 shares. Options are exercisable for a period of 10 years from date of grant.

(4) Reflects options to purchase 13,462 and 10,000 shares of common stock owned by Mr. Weed.
