- (1) On June 21, 2007 the board of directors made a grant of 30,000 restricted share to Mr. Karnes. The grant vests over four years. Twenty-five percent (25%), or 7,500 shares of the restricted stock grant vests on June 21, 2008. Additional blocks of 1,875 shares vest every three months after June 21, 2008 until the grant is fully vested on April 1, 2011; vesting accelerates upon a change of control and certain other circumstances.
