This statement is filed with respect to the shares of the common stock, \$.001 par value (the "Common Stock"), of Epicor Software Corporation (the "Issuer"), beneficially owned by Elliott Associates, L.P. and its wholly-owned subsidiaries ("Elliott"), Elliott International, L.P. ("Elliott International"), and Elliott International Capital Advisers Inc. ("EICA" and collectively, the "Reporting Persons") as of March 5, 2009 and amends and supplements the Schedule 13D filed on August 18, 2008, as previously amended (collectively, the "Schedule 13D"). Except as set forth herein, the Schedule 13D is unmodified.

### **ITEM 3. Source and Amount of Funds or Other Consideration.**

### **ITEM 5. Interest in Securities of the Issuer.**

(a) Elliott beneficially owns 4,241,738 shares of Common Stock, consisting of: (i) 3,138,401 shares of Common Stock and (ii) 2-3/8% Convertible Bonds due May 15, 2027 ("Convertible Bonds") convertible into 1,103,337 shares of Common Stock. Elliott owns its Convertible Bonds through The Liverpool Limited Partnership, a wholly-owned subsidiary of Elliott. The 4,241,738 shares of Common Stock constitute 7.0% of all of the outstanding shares of Common Stock.

Elliott International and EICA beneficially own an aggregate of 6,362,604 shares of Common Stock, consisting of: (i) 4,707,599 shares of Common Stock and (ii) Convertible Bonds convertible into 1,655,005 shares of Common Stock. The 6,362,604 shares of Common Stock constitute 10.3% of all of the outstanding shares of Common Stock.

Collectively, Elliott, Elliott International and EICA beneficially own 10,604,342 shares of Common Stock constituting 16.9% of all of the outstanding shares of Common Stock.

(b) Elliott has the power to vote or direct the vote of, and to dispose or direct the disposition of, the shares of Common Stock beneficially owned by it.

Elliott International has the shared power with EICA to vote or direct the vote of, and to dispose or direct the disposition of, the shares of Common Stock owned by Elliott International. Information regarding each of Elliott International and EICA is set forth in Item 2 of this Schedule 13D and is expressly incorporated by reference herein.

(c) The transactions effected by the Reporting Persons during the past sixty (60) days other than those not previously reported on this Schedule 13D are set forth on Schedule 1 attached hereto. No other transactions with respect to the Common Stock that are required to be reported on Schedule 13D were effected by any of the Reporting Persons during the past sixty (60) days.
