Boucher, Jr. ("Boucher") holds discretionary investment authority. Shares reported as of 12/31/05 under shared dispositive authority include 16,666,667 shares which are receivable under the assumed conversion of \$15,000,00 par value of Canargo Senior Secured Convertible Notes due 07/24/09, which are convertible at \$.90 /per share. These Notes are owned by Ingalls & Snyder Value Partners, L.P. ("ISVP"), an investment partnership managed under an investment advisory contract by Ingalls & Snyder, LLC ("Ingalls") and other customers of Ingalls. At 12/31/05, Boucher, a Managing Director of Ingalls, and Gipson, a Senior Director of Ingalls, share the right to vote securities owned by ISVP. At 1/1/06 Adam Janovic, a Senior Director of Ingalls became general partner of ISVP.
