(Tech II), respectively. 3,458,100 shares of Common Stock and 1,593,940 Wts are held by QP, 1,325,647 shares of Common Stock and 604,324 Wts are held by Cayman, 1,418,253 shares of Common Stock and 666,476 Wts are held by PE, 103,121 shares of Common Stock and 50,780 Wts are held by Tech and 552,826 shares of Common Stock and 270,644 Wts are held by Tech II. The interest of Marxe and Greenhouse in the shares of Common Stock owned by QP, Cayman, PE, Tech and Tech II is limited to the extent of his pecuniary interest.
