- (1) This represents restricted stock units originally awarded 2/23/05. Each restricted stock unit represents a contingent right to receive one share of the issuer's common stock. Subject to the reporting person's continued service with the issuer, the remainder of the award shall vest and the underlying shares of common stock shall be issued on 2/23/08.
- (2) This represents restricted stock units originally awarded 2/14/06. Each restricted stock unit represents a contingent right to receive one share of the issuer's common stock. Subject to the reporting person's continued service with the issuer, the remainder of the award shall vest and the underlying shares of common stock shall be issued in four equal, annual installments commencing on 2/14/08.
- (3) This represents restricted stock units originally awarded 2/1/07. Each restricted stock unit represents a contingent right to receive one share of the issuer's common stock. Subject to the reporting person's continued service with the issuer, the award shall vest and the underlying shares of common stock shall be issued in five equal, annual installments commencing on 2/1/08.
- (4) This represents restricted stock units awarded 6/1/07. Each restricted stock unit represents a contingent right to receive one share of the issuer's common stock. Subject to the reporting person's continued service with the issuer, the award shall vest and the underlying shares of common stock shall be issued in five equal, annual installments commencing on 6/1/08.
- (5) The resale restriction agreements the issuer entered into with certain employees, including the reporting person, upon the October 27, 2005 acceleration of the vesting of the issuer's outstanding options prevent the sale of any shares acquired from the exercise of an accelerated option prior to the earlier of the original vesting date of the option, or the reporting person's termination of employment. One third of this option is still subject to the resale restriction agreement.
- (6) This is an option for 18,000 shares with 1/4 exercisable 2/14/07, 2/14/08, 2/14/09 and 2/14/10.
