## SECTION 7 - REGULATION FD

### Item 7.01 Regulation FD

#### AAM's 2010 outlook:

- AAM expects full year sales in 2010 to be approximately \$2.28 billion.  
  
AAM expects to generate earnings before interest expense, income taxes and depreciation and amortization (EBITDA) ranging from \$335 million to \$345 million, and as a percentage of sales in the range of 14.5% - 15.0% in 2010.  
AAM believes that EBITDA is a meaningful measure of performance as it is commonly utilized by management and investors to analyze operating performance and entity valuation. AAM management, the investment community and the banking institutions routinely use EBITDA, together with other measures, to measure AAM's operating performance relative to other Tier 1 automotive suppliers. EBITDA should not be construed as income from operations, net income or cash flow from operating activities as determined under generally accepted accounting principles (GAAP). Other companies may calculate EBITDA differently.
- AAM expects full year capital spending in 2010 to approximate 4.7% of sales.
- AAM expects to report positive free cash flow in fourth quarter of 2010.  
AAM defines free cash flow to be net cash provided by (or used in) operating activities less capital expenditures net of proceeds from the sales of equipment and dividends paid.  
AAM believes free cash flow is a meaningful measure as it is commonly utilized by management and investors to assess the ability to generate cash flow from business operations to repay debt and return capital to stockholders. Other companies may calculate free cash flow differently.
- AAM's total available liquidity position at December 31, 2010 has grown to more than \$600 million.

#### AAM's 2011 Outlook

- AAM expects full year sales in 2011 to be approximately \$2.4 billion. This sales projection is based on the anticipated launch schedule of programs in AAM's new business backlog and the assumption that the U.S. Seasonally Adjusted Annual Rate of sales ("SAAR") increases from approximately 11.6 million vehicle units in 2010 to approximately 12.5 million vehicle units in 2011.  
  
AAM expects to generate earnings before interest expense, income taxes and depreciation and amortization (EBITDA) ranging from \$348 million to \$360 million, and as a percentage of sales in the range of 14.5% - 15.0% in 2011.
- AAM expects full year capital spending in 2011 to approximate 6.0% of sales to support AAM's \$850 million new business backlog, launching between 2011 - 2013.
