Confirmation of all securities held by institutions in book entry form (e.g., the FederalReserve Bank of Boston, the Depository Trust Company and various sub-custodians);

Reconciliation of all such securities to the books and records of the Company and The Bank of New York Mellon (the Custodian);

Confirmation of all securities hypothecated, pledged, placed in escrow, or out for transfer with brokers, pledgees, transfer agents or securities lending administrators;

Confirmation of all repurchase agreements with brokers/banks and agreement of underlying collateral with BNY Mellon records; and

Agreement of 5 security purchases and 5 security sales or maturities, if occurred, since our last report from the books and records of the Company to broker confirmations.

We believe that our examination provides a reasonable basis for our opinion. Our examination does not provide a legal determination on the Company's compliance with specified requirements.
