A managed account managed by Consonance Capital Opportunity Fund Management LP (“Consonance Opportunity”) directly holds 150,661 shares of the Issuer’s Common Stock (the “Managed Account Shares”). Capman is the general partner of Consonance Opportunity and Mitchell Blutt, as the Manager & Member of Capman, may be deemed to control Capman and Consonance Opportunity.
