- (1) On August 15, 2006, the Charles S. Hale Testamentary Trust ("Trust") contained 424,275 shares of Chemtura Corporation common stock. Hale now holds 212,138 shares of Chemtura Corporation common stock, for which Mr. Hale has sole dispositive power and for which he disclaims beneficial ownership.
