- (1) These shares were distributed by a family limited partnership over which the reporting person has control to the reporting person's daughter A and represented a portion of daughter A's pro rata interest in the shares of issuer stock owned by the partnership. The shares were initially distributed to a trust for the benefit of daughter A of which the reporting person serves as trustee, and the trust distributed the shares to a separate account for daughter A. The reporting person disclaims beneficial ownership of the shares owned by daughter A.
