- On June 18, 2009, RFR reorganized with RMR Real Estate Income Fund ("RIF"). In connection with this reorganization, Mr. Portnoy acquired an amount of RIF common shares with an aggregate net asset value equal to the aggregate net asset value of the RFR common shares owned by Mr. Portnoy on June 18, 2009, and Mr. Portnoy's RFR common shares were cancelled on the books of RFR and became null and void.
