#### Item 1.01 Entry Into A Material Definitive Agreement.

On January 13, 2012, Mack-Cali Realty Corporation (the General Partner ), the general partner of Mack-Cali Realty, L.P., announced that Michael Grossman was leaving his position as executive vice president of the General Partner effective immediately, and has agreed to stay on through January 31, 2012 to assist in the transition of his responsibilities. In connection with Mr. Grossman s departure, he entered into an Agreement and Release with the General Partner dated as of January 12, 2012 (the Agreement ). The Agreement provides for the severance benefits payable to Mr. Grossman pursuant to his employment agreement, including an aggregate cash payment of approximately \$1.1 million and accelerated vesting of 8,385 unvested shares of restricted common stock.
