CN announces election of directors

TORONTO, April 24, 2018 – CN (TSX: CNR) (NYSE: CNI) announced today that the director nominees listed in the management proxy circular dated March 6, 2018, were elected as directors of CN. The detailed results of the vote for the election of directors held at CN's Annual Meeting of Shareholders on April 24 in Toronto are set out below.

Election of Directors

On a vote by ballot, each of the following 12 nominees proposed by management was elected as a director of CN:
