- (4) 100% of the grant will vest on April 25, 2016.
- (5) The grant vest as follows: 1/48th of the grant vested on the vesting start date (1/6/2012) and 1/48th vests each month thereafter until the units are fully vested, subject to the Reporting Person's continued employment with Google on the applicable vesting dates.
- (6) 100% of the grant will vest on April 25, 2015, subject to the Reporting Person's continued employment with Google on such date.
- (7) 100% of this grant will vest on December 25, 2014, subject to continued employment with Google on such date.
