("CIT"), IMB Holdco LLC ("IMB"), Carbon Merger Sub LLC, a wholly wholly-owned subsidiary of CIT ("Merger Sub") and JCF III HoldCo I L.P., in its capacity as the holders' representative (the "Merger Agreement"), as amended by Amendment No. 1, dated July 21, 2015, pursuant to which IMB merged with and into Merger Sub with Merger Sub surviving as a wholly-owned subsidiary of CIT (the "Merger"). Pursuant to the terms of the Merger Agreement, as amended by the Amendment, CIT paid merger consideration consisting of cash and CIT common stock to holders of IMB common interests. Includes 2,522 unvested IMB common interests that converted to CIT RSUs and are scheduled to settle 100% in common stock of CIT on 3/8/2016. Includes 15,432.099 RSUs granted to filer on 8/3/2015 that are scheduled to settle 100% in common stock of CIT on 5/4/2016.
