(TSX: ONC, NASDAQ: ONCY) announced today that an abstract covering interim results of a Phase II study of intravenous REOLYSIN® in patients with sarcomas metastatic to the lung is available on the American Society of Clinical Oncology (ASCO) website at <a href="www.asco.org">www.asco.org</a> and on the Oncolytics website at <a href="www.oncolyticsbiotech.com">www.oncolyticsbiotech.com</a>.
