On June 8, 2007 the Company announced that it has closed its previously announced private placement of common shares for gross proceeds of CAD\$33 million. The offering was priced at \$2.50 per share.

Certain proceeds from the offering will be used to purchase Trinity Home Entertainment, LLC, a leading DVD distributor located in Westlake Village, CA, as well as Dufferin Gate Productions Inc., Toronto's foremost provider of production services and facilities. The balance of the net proceeds will be allocated to reducing debt, general working capital purposes and in support of potential future acquisitions. Westwind Partners Inc. acted as the lead agent in the

offering with a syndicate that included CIBC World Markets, Clarus Securities Inc. and Paradigm Capital Inc.

No stock exchange, securities commission or other regulatory authority has approved the information contained herein. The closing of the transactions described herein is subject to the negotiation and execution of definitive documentation and the approval of the Toronto Stock Exchange and the American Stock Exchange.
