- (1) These shares are held in a trust for the benefit of the reporting person's wife, who is the grantor and trustee of the trust.
- (2) Options become exercisable in 25% increments on the first, second, third and fourth anniversary dates of the grant.

- (3) Each restricted stock unit (RSU) represents a right to acquire one share of McDonald's Corporation common stock. Upon vesting, payout under the RSUs will be in the form of shares or, at the discretion of the Compensation Committee of the Board of Directors, the cash value thereof. No dividend, voting or other shareholder rights attach to the RSUs until they vest and only if the payout upon vesting is in shares of common stock.

- (4) Contain performance vesting condition based on diluted earnings per share growth during the performance period.
- (5) Each share of phantom stock represents the right to receive the cash value of one share of McDonald's Corporation common stock.
