The Restricted Stock Units (RSUs) will be settled solely with Issuer Common Stock upon an annual vesting schedule as provided for in the Award Agreement for the RSUs as follows: 2,176 shares not later than 11/15/2010, 2,112 shares not later than 11/15/2011, and 2,112 shares not later than 11/15/2012.
