- (1) Disposed of pursuant to a merger agreement (the "Merger Agreement") between Enventis Corporation, Consolidated Communications Holdings, Inc. ("Consolidated") and Sky Merger Sub Inc. in exchange for 7,976 shares of Consolidated common stock with a market value of \$208,891.44 on the effective date of the merger.
- (2) Disposed of pursuant to the Merger Agreement in exchange for 34,269 shares of Consolidated common stock with a market value of \$897,505.11 on the effective date of the merger.
- (3) This option, which is fully vested, is disposed of pursuant to the Merger Agreement in exchange for a cash payment of \$75,400 representing the difference between the exercise price of the option and the market value of Consolidated stock (calculated as a five-day average immediately prior to the effective date of the merger) times the exchange ratio of .7402.
