- (7) The reporting person's original Form 4 erroneously indicated that the number of NQOs was 217,850. This amended Form 4 is being filed to correct the number of NQOs.
- (8) The NQOs become vested with respect to one-third of the shares of Common Stock subject thereto on each of the first three anniversaries of the date of grant. Vesting of the NQOs is also subject to certain acceleration and termination provisions.
