(2) On December 30, 2010 Scott Summers Family Trust gifted 2,685 shares each of Common Stock to his children's trusts: 1)Patrick Summers, Trustee of the Christen Leigh Summers Trust 12/17/09; 2)Patrick Summers, Trustee of the Briana Lynn Summers Trust 12/17/09; 3)Patrick Summers, Trustee of the Danielle June Summers Trust 12/22/09. Total shares of common stock transferred 8,055. Patrick Summers is the brother of Scott E. Summers.
