(1) Shares held in trust with Mr. Lipps' wife.

If Omnicell meets certain total shareholder return objectives compared to the NASDAQ Healthcare Index, the units are scheduled to vest 25% at January 2, 2012, with the remaining shares vesting in equal increments once every six months over the subsequent 36 month

(4) period. The number of units that vest may be 0% to 120% of the target number of units, depending upon performance. The maximum number of units that may vest is 43,340. Vested restricted stock units will be paid in an equal number of shares of the Omnicell's common stock.

(5) Shares vest ratably over 48 months, with a 1 year cliff.
