Vested shares and accrued dividends will be delivered to the Reporting Person following each vesting date.
- (2) The time-based RSUs vest in two equal installments on each of October 1, 2019 and 2020, subject to the Reporting Person's continued service as a director with CUB through such date. Dividend equivalent rights accrue with respect to the RSUs when and as dividends are paid on CUB common stock and vest proportionately with the RSUs to which they relate. Vested shares and accrued dividends will be delivered to the Reporting Person following each vesting date.
