 As previously reported, on 12/12/11 the reporting person was granted 30,176 restricted stock units ("RSUs"), 10,058 of which vested on 12/12/12, and 10,059 of which will vest on each of 12/12/13 and 12/12/14. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The number of derivative securities in column 5 includes 253 vested dividend equivalent rights and a de minimus adjustment of 0.7263 due to fractional rounding of the dividend equivalent rights.
- (3) As previously reported, on 12/12/11 the reporting person was granted 51,208 restricted stock units ("RSUs"), 17,069 of which vested on 12/12/12, 17,069 of which will vest on 12/12/13, and 17,070 of which will vest on 12/12/14. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The number of derivative securities in column 5 includes 428 vested dividend equivalent rights and a de minimus adjustment of 0.3173 due to fractional rounding of the dividend equivalent rights.
