- (1) Non-Qualified Stock Options: Exercisable Date-Option vesting is over a four year period, vesting 25% on each anniversary of the grant date, contingent upon continued service to Invitrogen.
- (2) Restricted Share Units: Exercisable Date-Options are exercisable upon vesting after a three year period contingent upon continued service to the company. Expiration Date-Once vested, Restricted Share Units do not expire. They can be converted into shares of Invitrogen stock on the vest date.
- (3) Performance Shares: Exercisable Date-Shares are exercisable based on a target stock price. Expiration Date-Unvested Performance Shares expire on November 30, 2008.
