- (2) On 02/23/2010, the reporting person was granted an option to purchase 114,929 shares of Common Stock. The option vests based upon time (five equal annual installments that began on 2/23/2011) and performance (investment returns to investment funds affiliated with Bain Capital Partners, LLC, The Carlyle Group and Thomas H. Lee Partners, L.P. (collectively, the "Sponsors")) criteria. In total, as of the date hereof, the performance criteria has been met with respect to all of the shares of common stock subject to this option award (a portion of which has been exercised prior to the date hereof), with 28,471 of such shares still subject to issuance upon exercise having vested and become exercisable and the remaining 68,958 of such shares eligible to vest in three equal annual installments beginning on 2/23/2013.
