Unilever NV announces that on 23 March 2007 it purchased 250,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 21.52 and euro 21.85 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 132,567 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 56,191,196 Unilever NV ordinary shares in treasury, and has 1,658,536,504 Unilever NV ordinary shares in issue (excluding treasury shares).
