Unilever NV announces that on 3 May 2007 it purchased 800,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 23.159 and euro 23.165 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 151,332 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 63,798,358 Unilever NV ordinary shares in treasury, and has 1,650,929,342 Unilever NV ordinary shares in issue (excluding treasury shares).
